
There were two men by the name of David White in early nineteenth-century Ohio Township. One, the forebear of the prominent Clermont County funeral director T.P. White, came from New Jersey to Clermont County. The other, David White Sr. (ca. 1777-1851), came to southwest Ohio from Pennsylvania around the year 1796. His place of origin and parents are unknown, southwest Pennsylvania is likely.

This David White was a Justice of the Peace for Ohio Township; his name can be found on many early Clermont County marriage records. The 1880 Everts history of Clermont County notes of him, in its biography of his son David White, Jr., that "He [i.e., David Sr.] served as justice of the peace of Ohio township from 1815 to 1838, and finally declined any further re-elections. His magistrate's commissions, signed by Governors Thomas Worthington, Ethan Allen Brown, Allen Trimble, Jeremiah Morrow, Duncan McArthur, and Robert Lucas, are still preserved as heirlooms by his son David" (p. 428).

The commissions mentioned in the Everts history are currently owned by a direct descendant of David White, Jr. He has given his permission to place scans of the commissions on the Clermont County GenWeb site.






